United Power Celebrates 85 Years of Service at This Year’s Annual Meeting

United Power has been proudly serving members along the Colorado Front Range for 85 years – setting the standard for innovative excellence in system performance, technological adoption and deployment, member engagement, and commitment to community growth and development. The cooperative has accomplished a lot in the past year as it prepares for the upcoming exit from its wholesale power contract in May, including record reliability and groundbreaking energy partnerships, a renewed dedication to supporting key accounts while maintaining the same level of local involvement, and expanding member programs and self-serve options. Members are invited to attend the

2024 Annual Meeting on April 17 and join the cooperative in celebrating the many ways it is “Here for Good.”

Voting in the annual Director Election also provides United Power members the unique opportunity to have a voice in the cooperative’s future. Each year, your votes determine who will serve on the Board of Directors. Member participation in the election is crucial to helping the cooperative better serve you.

Five candidates are running for election to the Board of Directors this year. One seat in the Mountain, North, Central, and South Districts is up for election. The director candidates are Stephen Whiteside (incumbent) in the Mountain District; Brian A. McCormick (incumbent) in the North District; Tim Erickson (incumbent) and Paige Wagner-Maul in the Central District; and Brad Case (incumbent) in the South District. Consider attending the Meet the Candidates event on March 19 to learn more about director candidates (**details on pg. 3**) and read their candidate statements in this issue.

A bylaw amendment is included on this year’s ballot regarding director term lengths. Members are being asked if director terms should be changed from three years to four years.

Balloting opens on March 15. United Power encourages all members to cast their votes in the election. Members may vote electronically through their online account or via mail ballots, sent to all members. Online and mail-in ballots must be received by 11:59 a.m. on April 16, or members can vote in person on April 17 at the meeting. Ballot drop boxes will not be available in cooperative offices this year, however a ballot drop box will be available on-site at the Annual Meeting from noon to 4 p.m. Directors represent all members and are therefore elected on an “at-large” basis. This means members may cast a vote for a director in each district and not just their own. Directors serve in geographic districts to ensure accessibility for members and to provide a representative cross-section of United Power’s member base in the co-op’s governing body.

Attend the Annual Meeting

The 2024 Annual Meeting will be held at Riverdale Regional Park on April 17. Registration opens at 4:30 p.m. and balloting closes at the beginning of the official business meeting at 6:30 p.m. Members may also view a livestream of the meeting, available online at www.unitedpower.com/annual-meeting.

I have spent much of my 30+ year career in the utility industry. Through the years, people have often asked me what the “best” business model is to provide electricity. There are basically three choices: investor-owned utilities, municipal utilities, and cooperatives like United Power.

I try to reflect on the various pluses and minuses of each business model when answering the question, but always come back to the same conclusion — cooperatives are the closest to their member-owners, focus clearly on the communities being served, and can make changes quickly as technology transforms the energy enterprise.

Commitment to our member-owners is deeply embedded in the cooperative mindset. Our employees work diligently each day to meet the needs of United Power members, while also anticipating future needs. This is why we have been able to handle the tremendous growth in our service territory across all the sectors we are proud to serve: residential, small commercial, and large commercial/industrial. Our attitude and culture is to meet needs when and where they arise, based on the members' time frame.

Members have an active voice in the utility's future direction through the annual Director Election. The dedicated women and men on United Power's Board of Directors spend many hours alongside management preparing for what is to come. This is particularly important with the rapidly changing environment we find ourselves in today.

The Board had the foresight to pilot the largest battery storage facility in the West in 2018. It provided understanding and experience in operating battery storage systems, and paved the way for the cooperative to add another 115 megawatts of battery storage to our system this spring and summer. This battery deployment ensures reliability and allows us to manage the system locally. We will be one of the first utilities in the nation to energize utility-scale batteries at our substations. Moving quickly and taking advantage of innovative technologies is a hallmark of the cooperative world, and certainly at United Power.

Our theme for this year — United Power's 85th anniversary — is Here for Good. This captures our belief in building a reliable and resilient distribution system and our enduring presence in the communities we serve. United Power fosters local relationships and partners on economic development to support community growth. The cooperative also partners with members who want to give back to those less fortunate through Operation Round Up. More than 25,000 of you participate in the program, which has distributed more than \$3 million since 1995. This is why the cooperative business model is so strong — the proximity to the people we serve as “members” and not just “customers.”

As a member, you are also an owner with a vested economic interest in United Power. A part of every monthly statement is an investment in your utility — a key difference in the three business models. Every year, the Board of Directors evaluates our financial condition and determines if we can return margins to members. In the last five years alone, we have returned more than \$25 million to members. This only happens in the cooperative world (unless you own stock in an investor-owned utility, of course).

Electric cooperatives are based on seven principles: open and voluntary membership; democratic member control; members economic participation; autonomy and independence; education, training, and information; cooperation among cooperatives; and concern for community. We take these principle to heart in everything we do at United Power.

My third anniversary at the helm of United Power is March 15. I am thankful every day to live and work in a community powered by an electric cooperative, and to work with the amazing women and men of this utility.

MOUNTAIN DISTRICT

The following statements are those of the candidates and have not been altered or verified by United Power.



Stephen Whiteside (Incumbent)

Stephen Whiteside currently serves on the United Power Board of Directors (Mountain District) and is seeking re-election to his second term. His board duties include the Audit Committee and Assistant Secretary/Treasurer. He previously served 16 years

as a volunteer Director for United Power's Round-up Foundation, which is a community-focused effort to provide financial assistance to members with emergency needs. Whiteside has completed 18 educational courses offered by the National Rural Electric Cooperative Association and has earned the Credentialed Cooperative Director designation, Board Leadership Certification and Gold Leadership Certification. He is a lifelong Coloradoan, lives in Coal Creek Canyon and has been a member of United Power for 35 years. Whiteside is a graduate of the University of Colorado and owner of Whiteside's Boots in Brighton and Greeley.

"As a member-owned distribution cooperative, all United Power members have a direct stake in the management and future of the company by participating in the democratic election of the Board of Directors. As a Director, I have a fiduciary duty, along with fellow Board members and United Power management, to oversee the business of our co-op. My goals are straightforward -- using an all-of-the-above approach to provide the most reliable, the most affordable and the safest power to our members. I rely on my business background, education and experience when making Board decisions on oversight and governance.

Exciting opportunities lay ahead. The utility industry is rapidly evolving, and United Power is at the forefront of this great transition.

Most importantly, instead of a single power provider, we are developing a portfolio of power resources with a mix of traditional, low carbon, battery storage and renewables with the capability to meet our reliability and demand requirements. The one-size-fits-all model of the past is no longer the best power supply option. Our new mix of power resources will allow United Power to better control costs, utilize more local energy, and enhance efficiency and resiliency by participating in expanding power markets. The future is bright."

Other important issues at United Power:

- Fiscal responsibility and risk management. Only a financially sound business can be successful -- and United Power has 85 years of success.
- A consistent focus on safety for employees and members. Regular safety meetings and training help keep safety awareness top-of-mind.
- United power is ranked in the top 5% nationally for reliability.
- United Power has developed a Cooperative Roadmap/10 Year Plan to define our strategic vision and measure our progress toward those goals.

National Work Zone Awareness Week

Recognized April 15-19, 2024

United Power would like to remind our members of the importance of staying aware when entering and exiting roadside work zone areas for both your safety and our crews' safety. Transportation accidents are one of the leading causes of on-the-job deaths nationwide.

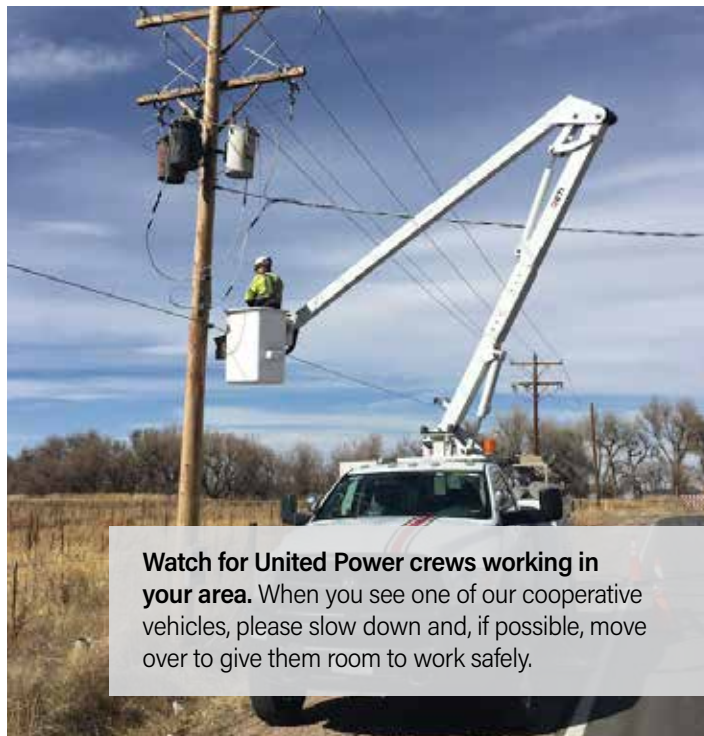
As an electric utility, our work is fundamentally different from most highway construction work zones. When United Power conducts roadside construction work, it usually involves small crews working for short periods of time when compared to major highway and road construction. This poses challenges to keeping our lineworkers safe.

Major traffic construction will warn drivers in advance with signs posted hundreds of feet or even miles prior to the beginning of work. However, because the nature of our work is different, our crews use different warning techniques when preparing for roadside work. Traffic cones are typically used to delineate our work, which are quicker and easier for our crews to haul and set up when work near roadways is required. Much of our electrical infrastructure is located in high traffic areas, such as shoulders and right of ways, intersections, and road medians.

To maintain high-powered electrical lines and equipment, our crews work in large vehicles, such as a bucket truck. When you see a United Power bucket truck located on a roadside, remember to look for signs and cones that it may be a work zone. Slow down and move over when possible to give our crews a wide enough path to continue working safely.

Please try to avoid distractions like cell phones or changing radio stations when entering a roadside work zone, and be prepared for the unexpected.

We thank you for helping keep our crews safe!



Watch for United Power crews working in your area. When you see one of our cooperative vehicles, please slow down and, if possible, move over to give them room to work safely.

OFFICIAL NOTICE: Annual Meeting of Members

The Annual Meeting of Members of UNITED POWER, INC. will be held Wednesday, April 17, 2024, at 6:30 p.m. at the Waymire Dome at the Riverdale Regional Park, located at 9755 Henderson Road in Brighton, Colorado. Members can attend in-person or via livestream. Instructions for participating in the meeting virtually can be found on the cooperative's website at www.unitedpower.com.

The meeting will be for the purposes of electing directors, deciding on a bylaw amendment brought forward by the board of directors, considering and approving reports for the prior fiscal year, and transacting such other business as may properly come before the meeting.

This year there are elections in the following districts: North, Central, South, and Mountain for three-year terms. The candidates nominated by petition are Brian A. McCormick (incumbent) in the North District; Tim Erickson (incumbent) and Paige Wagner-Maul in the Central District; Brad Case (incumbent) in the South District; and Stephen Whiteside (incumbent) in the Mountain District. All Members are entitled to cast a vote for the director positions of every district, regardless of the district where the Member is domiciled.

Members will also be voting on a change to the bylaws as follows:

Shall there be an amendment to Article 4, Section 4 of the Bylaws of United Power, Inc. to lengthen the term a Director holds office from three (3) years to four (4) years?

4.04 Term: Each Director, except as provided in Section 4.07, shall be elected to hold office for a term of ~~three (3)~~ **four (4)** years, or until his or her successor has been elected and qualified. The terms of the directors shall be staggered so that the tenure of not more than one (1) Director from each district expires each year. The tenure of office of all Directors shall be subject to the provisions of these Bylaws.

Members will receive notifications during peak events, which will only occur weekdays between 12 p.m. and 9 p.m. and last no more than four hours. Your thermostat will automatically return to normal at the end of the event. There will never be more than three events in a week. Members will see their credits on billing statements at the end of each cooling season, typically in October.
