

Official Rules – United Power EV Showcase Grand Prize Drawing

These Official Rules (“rules”) for the United Power EV Showcase Bill Credit Drawing (“drawing”) set forth the method of entry, method of selecting the winner, the term, and other conditions for participation.

Eligible Participants/Entrants – This drawing is open to persons who are at least eighteen years of age at the time of entry. To be eligible, the attendee must be a United Power member and satisfy the method of entry stated below. Each household or business is limited to one entry during the term of this drawing. Duplicate entries will be disregarded and will not increase the participant’s chances of winning. Employees and Directors of United Power and their immediate family members are not eligible to enter.

Methods of Entry – To enter for a chance to win, eligible participants must register at United Power’s EV Showcase at the Carbon Valley Service Center, 9586 E I-25 Frontage Rd, Longmont, CO 80504. Registration will take place on-site at the event on September 26, 2026. Only one ticket will be provided per adult attendee or household.

Term – The entry period begins at 9:00 AM on September 26, 2026 and ends at 11:00 AM on September 26, 2026. Entries must be received within this period or they will be void.

Prize – Five winners will be selected to receive one \$100 bill credit (\$100.00 value). Winners are not eligible to receive cash prize equivalents or substitute prizes. The drawing is administered solely by United Power, Inc. located at 500 Cooperative Way, Brighton, CO 80603. Any questions regarding these rules should be directed to United Power at the same address.

No Purchase Necessary - No purchase or payment of any kind is necessary to enter or win this drawing.

Selection of Winner – United Power will randomly select potential winners from all eligible entries after 11:00 a.m. on September 28, 2026 and notify the winners via email. Selected potential winners must claim their prize.

United Power reserves the right to verify that selected potential winners meets the eligibility conditions. If a selected winner does not meet the conditions of eligibility or fails to claim the prize within a reasonable amount of time after being notified, in United Power’s sole discretion, United Power may select a new potential winner. If a winner refuses or otherwise fails to claim the prize, United Power reserves the right to determine that the prize has been forfeited and there will be no winner for the forfeited prize.

Odds of Winning – Entry does not guarantee the participant will win a prize. Odds of winning a prize depend on the number of participants in this drawing. Each participant has an equal opportunity to win a prize. For example, if there are 500 participants, the odds of being selected as a winner are 1 out of 100.
