Electric Cooperative Association's (NRECA) annual meeting in 1957. The keynote speaker, Senate Majority Leader Lyndon B. Johnson, suggested sending youth to the nation's capital to "see what the flag stands for and represents."

During the summer Youth Tour, cooperatives from across the country send more than 1,300 students to Washington. The week-long trip includes meetings with local elected officials in Congress and tours of historical monuments around the capital. Students also learn the value of the cooperatives they represent. This year, United Power sponsored three ambitious and exemplary high school students to participate on the Youth Tour – Haley Eaton, Frederick High School; Allison McCormick, Frederick High School; and Aryan Sudheer, Prospect Ridge Academy.

Before departing for Washington, students from Colorado and Wyoming toured the State Capitol in Denver and the United Power headquarters in Brighton. They also heard presentations from previous Youth Tour representatives and about cooperative career paths.

"My time at Youth Tour allowed me to meet lifelong friends who share my interests and values, creating lasting connections through shared experiences," said Arnav Sudheer, one of United Power's representatives at the 2024 Youth Tour. "It also reinforced my passion for policy by giving me firsthand insight into the impact of civic engagement and the power of youth voices in shaping our future."

At the conclusion of Youth Tour, peers elect one student to represent their state on the Youth Leadership Council. The student selected as a delegate participates in the NRECA annual meeting the following March with other delegates from across the country. United Power Youth Tour representative Elizabeth Clement was selected as the Colorado delegate in 2022.

"I could not recommend this trip more because you get to see so many things in such a short amount of time and you learn so much," Clement said. "I did not even realize how much I was learning until the last day. I grew as a person on this trip."

Engaging with our communities is the best part of working for a cooperative. Whether it is answering a direct question from one of our members, supporting local fairs and festivals, or receiving input from our key accounts at quarterly meetings, the insight you provide helps us understand and respond to member needs. Listening to your needs is a critical component of how we operate.

Since I joined United Power in early 2021, we have seen amazing and continued growth. Loads have increased by more than 31% and our projected peak this summer is nearly 700 MW (for context, 1 MW is enough to power 700–1,000 average-sized homes). We have also added nearly 20,000 new meters, which is the size of an average cooperative in the United States. Annually, we add as many members as some smaller U.S. cooperatives have in total.

Ensuring we have sufficient power supply to serve growing loads now and for years to come meant we needed to expand our portfolio of power projects. Our power comes from a variety of technologies, ranging from hydropower and natural gas to solar and battery storage, bringing reliability and resilience to our distribution system and our members. And, of course, many members have added their own solar and storage resources and drive electric vehicles (EV). United Power's service territory has among the highest penetration of residential solar in the nation and more than 8,000 EVs.

The cooperative is fortunate to have a growing and well-diversified membership base nearly evenly split between oil and gas, commercial and industrial, and residential and small commercial. This allows for a balanced load factor on our system, resulting in high utilization of the electricity we provide for members.

Recently, we have had conversations with our oil and gas members to understand their needs and how we can support them as they strive to meet state regulations. Electrification of the oil and gas industry provides a cleaner way of producing their products and a more efficient use of resources, as is true of many parts of society. Closely coordinating with these members means we can leverage our reducedcarbon generating resources in alignment with their needs.

Data centers are also expanding their footprint in our territory. While some utilities are challenged by the influx of these energyintensive operations, we encourage these potential members to work with us in a coordinated fashion that aligns with the concept of "growth pays," as well as our move to expanding our distribution system operator plans.

It is especially important that we hear from our members directly about our \$262 million grant through the Empowering Rural America (New ERA) program. One of the cornerstones of the program has been developing our Community Benefit Plan (CBP). We are asking for your input on how our CBP initiatives can help local communities. Our first outreach was at Brighton Summerfest in early June, where dozens of members "voted" for their top three (out of seven) projects to be implemented as part of the CBP. There will be additional opportunities throughout the summer to participate, including multiple days at the Adams County Fair. Members may also let us know their favorite projects on the co-op website at www.unitedpower.com/new-era. We want to hear from you!

It is a privilege to work with the tremendous people here at United Power, supported by an active and engaged Board of Directors, as we enact *Our Cooperative Roadmap*. Engaging with our members makes us strong.

As always, please feel free to reach out with your questions, comments, or concerns or if you would like to discuss the CBP or New ERA grant program. I enjoy hearing from you and appreciate your continued support. Have a safe and enjoyable summer.

The Best Barbecue Beans

1 lb small dried beans, rinsed 2 Tbsp kosher salt 8 oz sliced bacon, cut into 1/2 in. strips 11/2 cups yellow onion, finely minced 1/4 cup green bell pepper, diced 2 Tbsp jalapeño, finely diced 1 Tbsp garlic, minced 2 cups chicken stock 11/2 cups ketchup 2/3 cup dark brown sugar 1/3 cup honey 1/4 cup molasses 2 Tbsp yellow mustard 1 Tbsp apple cider vinegar 1 Tbsp barbecue seasoning 1 Tbsp hot sauce Dissolve salt in 2 quarts water. Add beans, cover, and let stand overnight.

Preheat oven to 300°F. Cook bacon in large dutch oven until crisped. Transfer to plate. Add onion in same pot and cook until softened in leftover bacon fat. Stir in jalapeño and garlic, and cook until fragrant. Stir in 3 cups water, stock, bacon, and beans. Bring to boil, then simmer for 1 hour. Stir in remaining ingredients. Cover and cook in oven for 4 hours, stirring occasionally. Remove cover and cook one more hour.

Safety Around Pad-Mounted Transformers

Pad-mounted transformers lower high voltage electricity to the standard household voltage used to power electronics, appliances, and lighting. They are mounted on slabs of concrete near many homes and businesses. This equipment sits on an easement that allows United Power to perform necessary maintenance work.

Crews also need access to restore service during a power outage.

GIVE THEM SPACE

United Power lineworkers need a clearance of 10 ft. in front of a pad-mounted transformer to safely work on high-voltage power.

It may be tempting to "camouflage" transformers with landscaping, fences, shrubs, or trees. But objects that are located too close to transformers can slow restoration work during an outage, create a serious safety hazard, and may need to be removed when lineworkers need to gain access.

SAFE SPACE GUIDELINES

- Provide 10 ft. of clearance in front of a transformer so crews can open the door and work with their safety tools.
- Allow at least 4 ft. of clearance on all other sides to ensure crews have the ability to move about safely.

By keeping the area around a pad-mounted transformer clear from debris, vegetation, fencing, and building structures, you can help avoid outages, aid in the quick restoration of service in emergency situations, and avoid unnecessary costs.



LEAVE SPACE AROUND TRANSFORMERS



Do not plant shrubs or trees around transformers. United Power will cut back any vegetation in an emergency.



Objects in front of transformers restricts access. United Power must remove this fence in an emergency.



Never dig near a pad-mounted transformer. High-voltage cables run underground near this equipment.

Keeping Bills Low As Summer Heat Rises

How to Control Your Usage and Keep Summer Bills Manageable

Hot summer months can lead to increased energy use. Scorching heat outside could have your air conditioner working overtime to keep you comfortable inside your home.

Your home's largest energy-user and most demand-intensive appliance is your air conditioner, accounting for more than 15% of your total annual energy use. This means that when you reach for your thermostat there will be a corresponding rise in your energy bill to accommodate the increased use. Practicing energy saving behaviors can keep you cool and also keep your costs lower. Here are some tips to help you save energy and money:

- Turn up the A/C a few degrees. A few ٠ degrees can result in noticeable savings without making you uncomfortable.
- Pair A/C with a fan. Fans do not actually cool the air in your home. Instead, they

displace warmer air and create a "wind chill" effect making you feel cooler. Remember to turn fans off in empty rooms to save even more.

- Install a smart thermostat. Smart thermostats can learn your routines and be adjusted remotely to save energy. This makes it easier to preheat and precool your home while you are away so it is comfortable when you return without using excessive energy. Members can also enroll in Smart Rewards to earn an additional \$30 each cooling season. Learn more about the Smart Rewards program at www.unitedpower.com/smart-rewards.
- Avoid Appliance Stacking. Using multiple major appliances at once, such as cooking while doing laundry, can drive up demand costs. Spread the use

The Board of Directors proposes to amend the Bylaws of United Power, Inc. (United Power) as follows:

- Replace the word "nonprofit" with "not-for-profit" because there is a legal and operational distinction between the two types of organizations and United Power is a not-for-profit. This correction will align the cooperative's governing documents with its IRS filing status, note purchase agreements, and related indenture agreements.
- Include language that provides a deadline for a challenge to any election of directors. Notice of the deadline will provide guidance to members and staff on how to handle any challenges to an election. Clarity in the rules will improve the cooperative's operational efficiency.

A complete redline of the proposed changes is available on the cooperative's website at www.unitedpower.com, or members may obtain a hardcopy at any United Power office or via mail by calling 303-637-1300 and requesting that a copy be made available to them at the address on file with the cooperative.

Pursuant to Article 11, Section 8 of the Bylaws of United Power Inc., you are hereby notified that the Board of Directors of United Power proposes to adopt the amendment(s) to United Power's bylaws at a meeting of the Board to be held on Aug. 27, 2025, unless a written petition is filed at United Power's headquarters before close of business on Aug. 25, 2025, signed by 100 or more members, protesting the proposed amendments.

Notice of Change in the Regulations and Tariffs of United Power, Inc. DATE OF NOTICE: June 20, 2025

You are hereby notified that UNITED POWER, INC. (United Power) proposes to make changes to its Rules and Regulations and Electric Rate Sheet No. 9.1 to become effective on or after Aug. 1, 2025.

The elected governing body, specifically, the United Power Board of Directors has determined the cooperative's Rules and Regulations and Electric Rate Sheet No. 9.1 require updates to:

- correct references to outdated sections or numerals;
- remove duplicate and confusing language in an effort to streamline the Rules and Regulations to promote member understanding;
- provide guidance on disconnections during extreme weather events consistent with Colorado statute;
- provide notice of United Power's handling of construction deposits that may be applied to damage claims;
- update application fees to align with increased market and operational costs;
- provide guidance on United Power's notification process for planned outages; and
- provide clarity about United Power's regulations governing member • complaints.

The present and proposed Rules and Regulations and Rate Sheet No. 9.1 are available for examination at the Coal Creek branch office located at 5 Gross Dam Road, Golden, CO; the headquarters office located at 500 Cooperative Way, Brighton, CO; and the Carbon Valley Service Center office located at 9586 E. I-25 Frontage Road, Longmont, CO.

Anyone who desires to comment about the proposed changes may submit written comments with United Power at 500 Cooperative Way, Brighton, CO 80603 at least 10 days before the proposed effective date. Anyone who desires to file a complaint about the proposed changes shall submit that complaint in writing and shall include such facts and other information to adequately state the reason(s) for the complaint. Any complaint regarding the proposed Rules and Regulations and Electric Rate Sheet No. 9.1 changes shall be considered by United Power consistent with the currently effective Rules and Regulations.

Rebate Gets State Boost

New EV Wiring Rebate Available for United Power **Members While Funds Last**

United Power members can take advantage of additional electric vehicle (EV) wiring rebate dollars thanks to a grant from the State of Colorado's Community Access Enterprise (CAE) fund. The grant funds the EV Home Charge program, which provides two additional rebates for United Power members to offset the costs of charging an EV at home.

United Power members can access new rebate options for EV make-ready wiring and a separate rebate to cover associated electrical panel upgrades to add an EV home charger. Members who enroll in United EV, the cooperative's at-home EV charging program, still qualify for a larger rebate amount.

EV Home Charge rebates from the CAE are limited to funds availability.

The Colorado legislature created the CAE to support statewide use of electric transportation options and provide funding through grants, rebates, and other incentive packages for Colorado residents.

EV Make-Ready Wiring Rebate

Rebate is for the invoiced cost of a licensed electrician to install wiring and panel upgrades for a NEMA 14-50 outlet for a Level 2 EV charger.

United Power members can choose one of the two rebate options. EV make-ready wiring rebates cannot be combined.
